



Important information to consider when choosing your course

MSc Medical Ultrasound

When students are considering applying for the MSc Medical Ultrasound course they should be aware of the following:

- The attendance for this part-time course takes place in block delivery (normally two days, maximum of 4 days).
- Students will need to secure their own clinical placements and clinical placement Practice Educator. A Deputy Practice Educator/Second Assessor will be required to undertake the clinical assessments. The team acknowledge that some sites will not have access to a Deputy/Second Assessor. This must be discussed with the course lead at the time of application to ensure that a suitable member of the academic team can facilitate as the moderator. When students apply for the course they will need to complete a Clinical Workplace Agreement Form (signed by their workplace supervisor/mentor). This will identify who will be supervising their scans, the machines and QA and patient throughput so we can ensure that the clinical requirements of the course can be met by the student. The arrangements will need to be agreed by the Course Leader.
- It may be possible for students to undertake clinical placements at the Ultrasound Clinic. If students undertake an ultrasound clinical placement at AECC they should expect to attend a minimum of 2 clinical placement days per month, for each clinical application, for a period of at least 6 months. The current cost for each clinical placement day is £265 (2023-24). (Contact: ultrasoundplacement@aecc.ac.uk for further details on the AECC Ultrasound Clinic, clinical placements.) Places are limited and as such students will be interviewed as part of the application, students will be informed as soon as possible if they are successful. Please note that the Ultrasound Clinic at AECC UC is run as a separate entity to the MSc. Medical Ultrasound Course.
- **Practical Ultrasound Assessments:** Practical assessments will take place at the student's placement site. For students attending the placement site at AECC Ultrasound Clinic whenever possible a student will be assessed on one day, normally in May or early June. Students will be notified of their assessment date by early April. All other students will be assessed at the student's placement site with their Practice Educator in attendance and a AECC UC moderator. *(Where different assessment arrangements are required these may incur additional costs. Please see the additional costs information below).*
- For the MSc Medical Ultrasound course the pass mark is 50%

Additional Costs

Additional costs are mandatory or optional costs which students will need to meet in order to fully participate in and complete their course. Students will need to budget for these

costs separately as they are not included in the overall Tuition Fee they are charged.

- Some assignments require the submission of a printed paper copy. The cost of printing and postage is the students' responsibility and will vary depending on the length of the assignment. There are no photocopying or printing credits provided.
- Students will be responsible for funding their own travel and accommodation when attending units, assessment or CPD seminars and when attending meetings with their supervisor for the dissertation and clinical audit units (normally at least two meetings required). Where appropriate, meetings with supervisors will be offered via Teams.
- *External Assessments:* If assessment at the place of work is not possible because the distance is prohibitive the student will be assessed at an appropriate venue at the discretion of the Course Leader. There are additional costs of up to £1000 per assessment (2023-24 prices) and these will be payable one month in advance of the assessments. Students will be advised of the fee at the time of booking. If a student cancels less than one month in advance of the assessment the student will be liable for any expenses incurred in preparation of the assessment.
- *External Reassessments:* The normal fee to be reassessed at the student's place of work is £265 (2023-24 prices). This may change, at our discretion, subject to circumstances and the assessment venue. Students will be advised of the fee at the time of booking. The fee must be paid to us one month prior to the assessment.
- Log books sheets require the submission of a printed paper copy. The cost of this is the students' responsibility and will vary depending on the length. There are no photocopying or printing credits provided
- *On-site Ultrasound Assessments:* If a student is unable to attend the set assessment date there will be an additional fee to arrange this. If a student cancels less than one month in advance or fails to attend the agreed Musculoskeletal assessment, a charge of £265 will be payable (2023-24 prices).
- *On-site Ultrasound Reassessments:* The normal fee for a reassessment at the Ultrasound Clinic is £265 (2023-24 prices). You will be notified prior to the reassessment if a reassessment fee is payable. The fee must be paid to us one month prior to the assessment.
- Students who undertake their clinical placements outside of the United Kingdom will be responsible for the associated costs of assessments in those countries.
- On successful completion of the course students have the option to attend the graduation ceremony. Students choosing to attend must meet the cost of hiring academic dress for the ceremony; wearing of academic dress at the ceremony is

compulsory. The academic dress is provided by an external company. In 2023 the hire cost was £38. There are no other charges to the graduate for the graduation ceremony. However, additional tickets for family members and friends are chargeable and you will be advised of the price when you are invited to graduation.

- You will be provided with transcripts for each year of study along with a diploma supplement and degree certificate upon completion of your course of study. If you require a replacement of any of these documents there will be a fee payable as set out below:
 - Transcript (per academic year): £10
 - Degree Certificate: £40
 - Diploma Supplement: £10

Where earlier prices are quoted these costs are not expected to increase by any substantial amount for 2024-25.
